 - (2) They shall come into force on the date of their publication in the Assam Gazette.
- 2. In the Right to Information (Regulation of Fee and Cost) Rules, 2005 -
 - (a) in rule 3, after the words "banker cheque", the words "or Indian Postal Order or non-judicial stamp" shall be inserted.
 - (b) in rule 4, after the words "banker cheque", the words "or Indian Postal Order or non-judicial stamp" shall be inserted.
 - (c) in rule 5, after the words "banker cheque", the words "or Indian Postal Order or non-judicial stamp" shall be inserted.
