NO.AR.78/2005/ 216 : In exercise of powers conferred by clauses (b) and (c) of sub-section 2 of section 27 of the Right to Information Act, 2005 (Central Act No.22 of 2005), the Governor of Assam is hereby pleased to make the following rules to amend the Assam Right to Information ( Regulation of Fees and Cost ) Rules , 2005 , namely :-

Short title and commencement -1.

(1) These rules may be called the Assam Right to Information ( Regulation of Fees and Cost ) (Amendment) Rules , 2015 .

(2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of rule 4                      2.

2. In the Principal Rules , in Rule 4 , for clause ( d ) the following clause shall be substituted ,namely :-

"(d) for inspection of records, no fee for the first hour and fee of rupees five each subsequent hour ( or fraction thereof )"
