The Governor of Assam is pleased to constitute a committee as per Section 15(3) of the Right to Information Act, 2005 for recommendation of the names of the State Chief Information Commissioner and State Information Commissioners to be appointed by the Governor for the purpose of exercising the powers conferred under the Right to Information Act, 2005 enacted by the Government of India to provide for setting out a practical regime of Right to Information for citizens to secure access to information under the control of public authorities, in order to promote transparency and accountability in the working of every public authority and for matters connected therewith or incidental thereto with following Members.

2. Shri Brindaban Goswami, Leader of Single Largest Group
in Opposition in Assam

Explanation :- *For the purposes of removal of doubts, it is hereby declared that where the Leader of Opposition in the Legislative Assembly has not been recognized as such, the Leader of the single largest group in opposition of the Government in the Legislative Assembly shall be deemed to be the Leader of Opposition.*

Under Section 15(3)

The Committee will devise its own procedure for selection of names and will recommend the names of suitable persons to be appointed as State Chief Information Commissioner and State Information Commissioners with qualifications as stated under section 15(5) and 15(6) of the Right to Information Act, 2005.

This will come into force with immediate effect.
