Dated Dispur, the 18th May, 2017.


No. AR 54/2017/Pt-11/15: In the interest of public service, the Governor of Assam is pleased to order the renaming of the Border Areas Department, Government of Assam as **“Border Protection and Development Department”**.

Consequently, the Governor of Assam is pleased to allocate the following subjects to the Border Protection and Development Department with immediate effect:

- i) All Inter-state border related matters with the states of Nagaland, Arunachal Pradesh, Meghalaya, Manipur, Mizoram, Tripura, West Bengal, including border disputes.
- ii) Indo-Bangla boundary matters –
 - a) Sealing of international boundary/border fencing.
 - b) Border pillars and roads.
 - c) Cattle Haats near IBB / Cattle-smuggling.
 - d) Issue of Identity Cards in IBB.
 - e) Relocation and realignment of IBB villages.
- iii) All matters relating to Indo-Bhutan boundary including border pillar and roads.
- iv) Establishment, Construction, repair & renovation of Border Out Post.
- v) All matters relating to border development Schemes (both Inter-state and international border).
- vi) Co-ordination with Home & Political Department for maintenance of Law and Order on border areas.
- vii) Co-ordination with other Departments in carrying out Plan/Programme along the inter-state borders (0-20 km) by these other Development Departments.
- viii) Historical records and preparation of reports thereon.
- ix) Establishment matter in respect of Research Cell.
- x) Commission of Inquiry/committee etc. constituted either by Govt. of India or by State Govt. of Border Areas.
- xi) Documentation of old records/maps on all boundary matters.
- xii) All miscellaneous matter relating to border Areas (Inter-state and International).

Consequent upon the issue of the order of renaming of the Border Areas Department, all the subordinate offices if any, will continue to be under the administrative control of the **“Border Protection and Development Department”** and shall automatically reorient their mandates and functions in tune with the above.
