Sub: Assam Right to Public Service Act,2012 for Issuance Certificate of Competency.

In pursuance of the Government's decision for formulation as well framing of the **Assam Right to Public Service Act,2012**, the following order comes into the force with immediate effect in exercise of power conferred under section 4 of the **Assam Right to Public Service Act,2012(Assam Act No IX of 2012)** and shall remain in force until further order. This order shall valid for Issuance of Certificate of Competency.

- a. This order shall guide the citizen's charter to know their rights about the procedural system for obtaining **Certificate of Competency** from the **O/o Director IWT**.
- b. This order shall apply for knowing details procedure /information regarding the **Issuance of Certificate of Competency** for those who become eligible to obtain the above certificate.
- c. In this order the following term is used in the sense explained herein below:-
"Notified Public Service":- The term notified public service means the prescribed services to be provided by the department concerned such as (1) **Issuance of Certificate of Competency**.

(1) **About Service in brief:-**"**Certificate of Competency**" is being carried out and delivered through the O/o Director IWT. The process includes written & Viva-Voce/Interview in two phases. The final merit list is made based on total marks secured by the candidate in the written test and the viva-voce/ interview. Candidates who obtain at least 40% marks in total are eligible for obtaining the "Certificate of Competency".

(2) **Eligibility criteria to obtain the service for citizens:** - Any candidate who desire to appear before the Examination board must apply on Form A (manually) to the Director, IWT along with examination fees, mandatory supporting documents and his service/ experience certificates issued by the respective authorities,as per the Inland Vessel Act, 1917.

(3) Procedure to obtain service -step by step procedure:

Step	Work	Estimated Timeline
1	<p>Application form (Form A) may be downloaded from the Director, IWT, Assam's website http://iwtdirectorate.assam.gov.in</p> <p>ii. Applicant has to prepare a list showing documents & DD of Rs. 100/ submitted along with the application enclosed with signature.</p> <p>iii. Applicant has to fill the form (Form A) in all aspects. Applicant writes the name of the Examination/Category applied for in "BOLD LETTERS" in the Envelope containing the application form & inserts the DD along with all the supporting documents in the envelope.</p> <p>iv. The applicant then submits their application in a sealed envelope and send "through post" only and addressed to the Director, Inland Water Transport, Assam, Ulubari, Guwahati-781007 & ensures that it reach to the concerned office before the last date.</p>	45 days (Without any Objection)
2	<p>Work Verification of documents to be carried out by the Dealing Asstt, reviewed by River Surveyor and approved/signed by Director in the office of IWT Directorate if pleased</p>	
3	<p>The candidates whose applications are accepted will be required to appear in a Viva-voce/Interview and Phase II-Practical test.</p> <p>□ The viva-voce held and Practical test will be held on the same day at the IWT, Assam premise.</p> <p>□ The candidates who qualify in the Viva Voice examination are eligible for appearing in the practical test.</p> <p>□ The final merit is made based on total marks secured by the candidate in the viva-voce interview and Practical test . Candidates who obtain at least 40% marks in total will be eligible for obtaining the "Certificate of Competency".</p> <p>The eligible Applicant receives the original copy of the "Certificate of Competency" issued from IWT Directorate, Assam</p>	

(4) **Prescribed application forms:** Annexure - A (Form A as per the Inland Vessel Act, 1917 from Inland Water Transport Directorate.)

(5) **List of documents to be enclosed with the application forms:-**

- Duly filled up application Form No. A [**Mandatory**]

- Original copy of the Demand Draft (DD) of Rs. 100/- drawn in favour of "Director, IWT, Assam" [**Mandatory**].
 - Address Proof of applicant – Passport, Bank Passbook, Voter ID, Electricity Bill, Aadhaar, Driving License, etc. [**Mandatory**]
 - ID Proof of applicant – PAN, Voter ID, Bank Passbook, Driving License, Passport, etc. [**Mandatory**]
 - Age Proof Certificate issued by a recognized Board/ Council or Birth Certificate issued by Government. [**Mandatory**]
 - Class IX (minimum) passing certificate or higher qualifications. [**Mandatory**]
 - Sea service certificate (minimum 3 years' service) should be on original letter head containing valid E-mail and phone number of the company and duly stamped. [**Mandatory**]
 - Certificate of Fitness and Eye sight test from registered Government Doctor. [**Mandatory**]
- (6) **Name of Service & Issuing authority:** Certificate of Competency signed by Examiner and countersigned by the Director, IWT.
- (7) **Designated Public Servant:** River Surveyor, IWT, Directorate
- (8) **Appellate Authority :** Director, IWT, Assam
- Stipulated time limit for disposal by Appellate authority:** 30 days


