(v) One case study on Best Good Governance Practice to be uploaded along with requisite pictures etc on the Dashboard to be made live by DARPG w.e.f 20.12.2021. The application form for uploading will be available on the week long campaign portal.
(vi) One case study of success story on resolution of public grievances by each State/District will also be captured on the Dashboard.
